

Ms. Sherlynn Chan, partner of Stevenson, Wong & Co., attended the STEP Asia Conference 2019 held between 5-6 November 2019 in Singapore. The Conference attracted hundreds of delegates from all around the globe, including legal practitioners, trust providers, and financial institutions.

The Conference's main theme was "opportunities in complexities". Day 1 began by delving deep into the changing macro landscape, such as economic substance, challenges to fiduciary providers and financial institutions workingwith Private Trust Companies and its significance to high net worth families and trust and estate practitioners. Day 2 focused on the micro landscape — the impact of UK tax changes on trustee, settlor and beneficiaries, and governance in family values and philanthropy through donor advised funds.

Under the topic of "New Legal Integration in GBA: Legal Practical Issues in Commercial and Family Affairs", Ms. Por, partner and the head of private client, discussed the different legal services that we may encounter at different stages of life, from cross-border marriage to family wealth planning, the establishment of trusts to probáte matters.

Mr. Lo, partner and the head of corporate finance, shared with guests how "one Country, Two Systems" can assist Mainland companies to enter the global financial market. By sharing the new 16 measures in the Greater Bay Area and the requirements of IPO's, Mr. Lo also analysed the advantages of setting up a company in the Greater Bay Area and the latest developments in the Hong Kong IPO market.

Ms. Heidi Chui, partner and the head of banking and Finance, Litigation and Disputes Resolution, explained the law and regulations under financial technology and innovation and shared her practical experience of establishing a new era of smart banking.
